Limited Travel Ban Exceptions



The New Zealand border is still closed to almost all travellers to help stop the spread of COVID-19. This travel ban applies to all arrivals into New Zealand whether it is by air or sea. Only New Zealand citizens, permanent residents and residents with valid travel conditions (excluding people granted a resident visa outside New Zealand and who are travelling to New Zealand on that resident visa for the first time) may travel to and enter New Zealand.

The good news is that there are a small number of additional, limited exceptions to the ban on travelling to and entering New Zealand. This applies to people who already hold a temporary visa as well as to people who don't. To see the list of people who may be considered for this travel exception read Immigration New Zealand's (INZ) Border Closures and Exceptions article.

In addition to the above-mentioned list of people, there may be opportunities to request an exception for candidates that are required in New Zealand for a *critical purpose*.
