The Department of Inland Revenue ("DIR") has released the attached notice (PN/Tax Returns/2020-01) dated 21st April 2020, informing all tax payers that due to the prevailing situation in the country consequent to the outbreak of COVID-19, an extension has been granted until 31st May 2020 for the submission of the following tax returns/ statements/ forms:

- Annual Declaration of Employer ("PAYE Tax Return") Year of assessment 2019/2020
- Annual Statement of Withholding Tax Year of Assessment 2019/2020
- Economic Service Charge ("ESC") Return Year of Assessment 2019/2020
- Compounded Stamp Duty Return for the quarter ending 31st March 2020
- Value Added Tax on Financial Services (VAT on FS) Interim Estimate for the last six months
 of the Year of Assessment 2019/2020 (for financial institutions which submit returns on year
 of assessment basis)
- Value Added Tax ("VAT") returns for the months of February and March, and quarter ending 31st March 2020
- Transfer Pricing Disclosure Form for the Year of Assessment 2018/2019.

Furthermore, this notice intimates that e-Filing facility is available through DIR's portal for taxpayers who wish to submit the VAT, ESC, PAYE Tax Returns and Withholding Tax Schedules for above periods.

Extension of Tax Return Submission Dates
PAYE, WHT, ESC, Stamp Duty, VAT on FS Interim Estimate &
Transfer Pricing Disclosure Form

Taking in to account the prevailing situation in the country the dates of submission for following Tax Returns has been extended up to **May 31, 2020.**

- Annual Declaration of Employer (PAYE Tax Return) Y/A 2019/2020
- Annual Statement of Withholding Tax (WHT) Y/A 2019/2020
- Economic Service Charge (ESC) Return Y/A 2019/2020
- Compounded Stamp Duty Return for the quarter ending March 31, 2020
- Value Added Tax on Financial Services (VAT on FS) Interim Estimate for last six months of the Year of Assessment 2019/2020 (financial institutions which submit returns on year of assessment basis)
- Value Added Tax (VAT) returns for the months of February, March and quarter ending March 31, 2020.
- Transfer Pricing Disclosure Form for the Y/A 2018/2019

However, e-Filing facility is available through IRD Portal e-Services for taxpayers who wish to submit the VAT, ESC, PAYE returns and withholding Schedules for above periods.
